
## 1. SAFETY

### 1.1. ELECTRICAL SAFETY

- WARNING!** It is the user's responsibility to check the following:  
Check all electrical equipment and appliances to ensure that they are safe before using. Inspect power supply leads, plugs and all electrical connections for wear and damage. Sealey recommend that an RCD (Residual Current Device) is used with all electrical products. You may obtain an RCD by contacting your local Sealey stockist.  
If the polisher is used in the course of business duties, it must be maintained in a safe condition and routinely PAT (Portable Appliance Test) tested.

**Electrical safety information.** It is important that the following information is read and understood.

- 1.1.1. Ensure that the insulation on all cables and on the appliance is safe before connecting it to the power supply.
- 1.1.2. Regularly inspect power supply cables and plugs for wear or damage and check all connections to ensure that they are secure.
- 1.1.3. Important: Ensure that the voltage rating on the appliance suits the power supply to be used and that the plug is fitted with the correct fuse - see fuse rating in these instructions.
  - × **DO NOT** pull or carry the appliance by the power cable.
  - × **DO NOT** pull the plug from the socket by the cable. Remove the plug from the socket by maintaining a firm grip on the plug.
  - × **DO NOT** use worn or damaged cables, plugs or connectors. Ensure that any faulty item is repaired or replaced immediately by a qualified electrician.
- 1.1.4. This product is fitted with a BS1363/A 13 Amp 3 pin plug.
- 1.1.5. If the cable or plug is damaged during use, switch the electricity supply and remove from use.
- 1.1.6. Replace a damaged plug with a BS1363/A 13 Amp 3 pin plug. If in doubt contact a qualified electrician.
- 1.1.7. Class II products are wired with live (brown) and neutral (blue) only are marked with the Class II symbol;
  - A) Connect the BROWN live wire to the live terminal 'L'.
  - B) Connect the BLUE neutral wire to the neutral terminal 'N'.
  - C) After wiring, check that there are no bare wires and ensure that all wires have been correctly connected.Ensure that the cable outer sheath extends inside the cable restraint and that the restraint is tight.
  - × **DO NOT** connect either wire to the earth terminal.Sealey recommend that repairs are carried out by a qualified electrician.



### 1.2. BATTERY SAFETY

- ✓ Charge battery prior to first use. The battery pack will have been shipped in a low charge state.
- ✓ Use only the charger provided to charge the polisher battery.
- × **DO NOT** charge battery when room temperature is below 50°F (10°C) or above 104°F (40°C).
- × **DO NOT** attempt recharging the battery by means of a generator or a DC power source.
- × **DO NOT** short-circuit the battery by linking both terminals with conductive materials.
- × **DO NOT** store the battery (or wrench) in locations where the temperature may exceed 104°F (40°C).
- ▲ **DANGER! DO NOT** attempt to dismantle the battery pack. For safety and environmental reasons **DO NOT** discard in domestic waste or by burning. **ONLY** discard or recycle according to local authority regulations.
- WARNING! DO NOT** allow a leaking battery to contact your person. If you come into contact with battery liquid take the following immediate action:
  - a) Skin contact: Wash immediately with soap and water, then wash flesh in either lemon juice or vinegar.
  - b) Eye contact: Wash with a strong solution of boric acid, and seek immediate medical attention.

### 1.3. BATTERY CHARGER SAFETY INSTRUCTIONS

- WARNING: DO NOT** use the charger to charge any battery other than that supplied for the polisher. Other types of batteries may explode.
- 1.3.1. All mains electrical supply safety features must be followed as described in 1.1. above.
- 1.3.2. Disconnect the charger from the mains power supply when not in use.  
Important: Check that the voltage marked on the charger is the same as the power supply to be used.
  - × **DO NOT** pull or carry the charger by the power lead, or pull the plug from the mains socket by the power lead.
  - × **DO NOT** use any other type of charger.
  - × **DO NOT** try to open or dismantle the charger.
  - × **DO NOT** get the charger wet, or use in wet, damp conditions (for indoor use only).
  - × **DO NOT** operate the charger if it or the battery is damaged.

- × **DO NOT** insert foreign objects or material into the hole reserved for the battery.
  - × **DO NOT** force the battery into the charger. The battery will only fit one way to ensure correct polarity alignment.
  - × **DO NOT** charge a second battery immediately. Consecutive charging will overheat the charger. Allow the unit to cool for 15 minutes before charging the next battery.
  - ✓ Store the charger in the same manner as the battery, see section 1.2.
- 1.4. GENERAL SAFETY.**
- ✓ Maintain the polisher and battery in good condition. Check moving parts alignment on a regular basis.
  - ✓ Replace or repair damaged parts. Use an authorised service agent and recommended parts only. Unauthorised parts may be dangerous and will invalidate the warranty.
  - ✓ Ensure the polisher is switched off before installing the battery pack.
  - ✓ Keep the polisher and charger clean for best and safest performance.
  - ✓ Remove ill fitting clothing. Remove ties, watches, rings and other loose jewellery and contain long hair.
  - ✓ Ensure battery pack is correctly inserted into the polisher handle and latched in place before attempting to switch on polisher.
  - ✓ Secure loose work pieces with a clamp, vice or other adequate holding device.
  - ✓ Avoid unintentional starting.
  - ✓ Wear approved safety eye protection (standard spectacles are not adequate).
  - ✓ Maintain correct balance and footing. Ensure the floor is not slippery and wear non-slip shoes.
  - ✓ Keep children and unauthorised persons away from the working area.
  - × **DO NOT** use the polisher where there are flammable liquids, solids or gases, such as paint solvents, etc.
  - × **DO NOT** allow children to operate the polisher.
  - × **DO NOT** operate the polisher if any parts are missing as this may cause failure and/or personal injury.
  - × **DO NOT** hold unsecured work piece in your hand.
  - × **DO NOT** leave the polisher operating unattended.
  - × **DO NOT** carry the polisher with your finger on the power switch.
  - × **DO NOT** use the polisher for a task it is not designed to perform.
  - × **DO NOT** operate the polisher when you are tired or under the influence of alcohol, drugs or intoxicating medication.
  - × **DO NOT** get the polisher or battery charger wet or use in damp or wet locations.

## 2. INTRODUCTION

Features variable speed control giving a range suitable for sanding and polishing up to 3000rpm. Soft grip handle for comfort and control. Locking swivel adjustment from pistol to straight type. Includes battery condition indicator. Supplied in canvas bag with 12V Lithium-ion battery pack, battery charger and a range of polishing and sanding heads.






## 5. OPERATION

- 5.1. Variable speed switch: adjust speed by holding down the variable speed switch fig.1.4.
- 5.2. Rotation of the handle: press the button fig.1.8 whilst turning to the preferred orientation.
- 5.3. Installing the sanding pad: press the spindle lock button and wind the sanding pad on (clockwise) then tighten it, fig.2.
- 5.4. Fit side handle: screw into body in a clockwise direction, can be fitted to either side, fig.3.



- 5.5. Approximate run time remaining.



- 5.6. Installing/removing battery pack: remove by depressing battery pack release button, fig.1.6 and pull the battery pack out. Install by pushing the battery pack, fig.1.7 back onto the tool until it locks into place.
- 5.7. Battery charger operation:  
Power on - green light  
Charging - red light  
Charged - green light
- 5.8. Accessories: only use Sealey recommended accessories and consumables.

## 6. MAINTENANCE

- WARNING!** unplug charger from the mains supply before cleaning it.
- 6.1. Regularly clean the charger using a soft brush or a dry cloth. **DO NOT** use any abrasive or solvent based cleaners.
- 6.2. Store in a dry, clean childproof place.

## **WARNING! – Risk of Hand Arm Vibration Injury.**

**This tool may cause Hand Arm Vibration Syndrome if its use is not managed adequately.**

This tool is subject to the vibration testing section of the Machinery Directive 2006/42/EC.

This tool is to be operated in accordance with these instructions.

**Measured vibration emission value (a): 1.43 m/s<sup>2</sup>**

**Uncertainty value (k): 1.5 m/s<sup>2</sup>**

*Please note that the application of the tool to a sole specialist task may produce a different average vibration emission. We recommend that a specific evaluation of the vibration emission is conducted prior to commencing with a specialist task.*

A health and safety assessment by the user (or employer) will need to be carried out to determine the suitable duration of use for each tool.

**NB:** Stated Vibration Emission values are type-test values and are intended to be typical.

Whilst in use, the actual value will vary considerably from and depend on many factors.

Such factors include; the operator, the task and the inserted tool or consumable.

**NB:** ensure that the length of leader hoses is sufficient to allow unrestricted use, as this also helps to reduce vibration.

*The state of maintenance of the tool itself is also an important factor, a poorly maintained tool will also increase the risk of Hand Arm Vibration Syndrome.*

### **Health surveillance.**

We recommend a programme of health surveillance to detect early symptoms of vibration injury so that management procedures can be modified accordingly.

### **Personal protective equipment.**

We are not aware of any personal protective equipment (PPE) that provides protection against vibration injury that may result from the uncontrolled use of this tool. We recommend a sufficient supply of clothing (including gloves) to enable the operator to remain warm and dry and maintain good blood circulation in fingers etc. Please note that the most effective protection is prevention, please refer to the Correct Use and Maintenance section in these instructions.
